COVID-19 Daily Briefing

August 28, 2020

Updated weekdays by approximately 12:30pm

Thirty new cases and one death have been reported since yesterday's daily briefing was issued. There have been 6,014 laboratory-confirmed cases in Forsyth County. All cases reported by the Forsyth County Department of Public Health are Forsyth County residents. Of the 6,014, 5,312 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

The Public Health Director will provide a detailed briefing at 2:00pm at the beginning of the September 3rd Board of County Commissioners meeting, which will be conducted remotely. 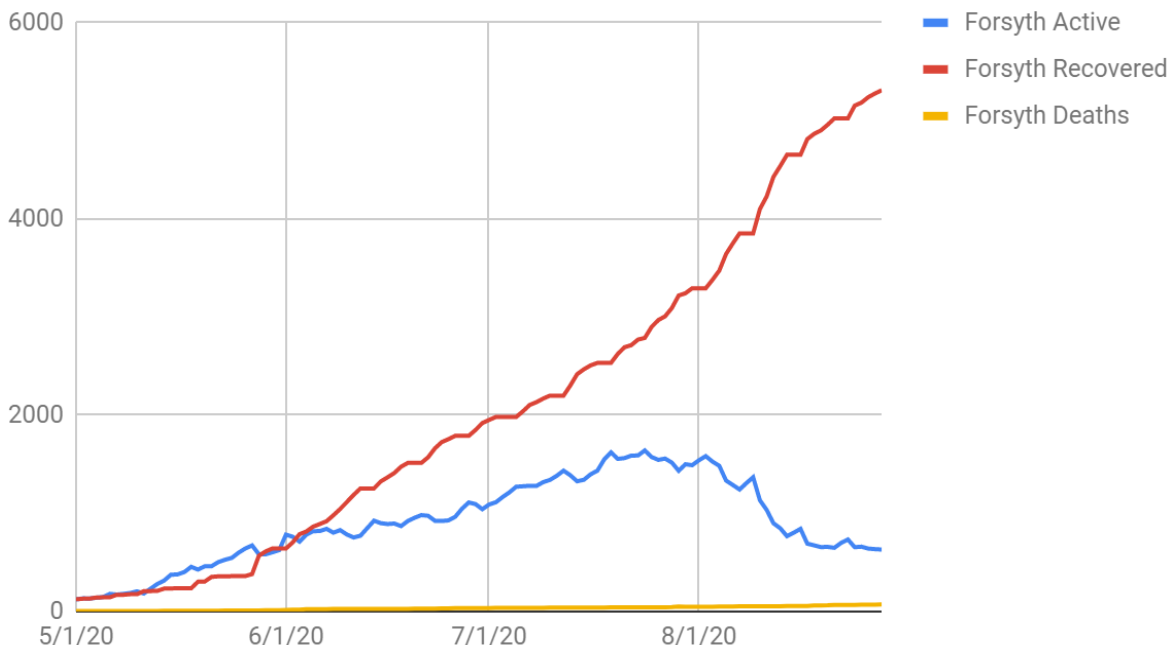
Public Health Director Comment

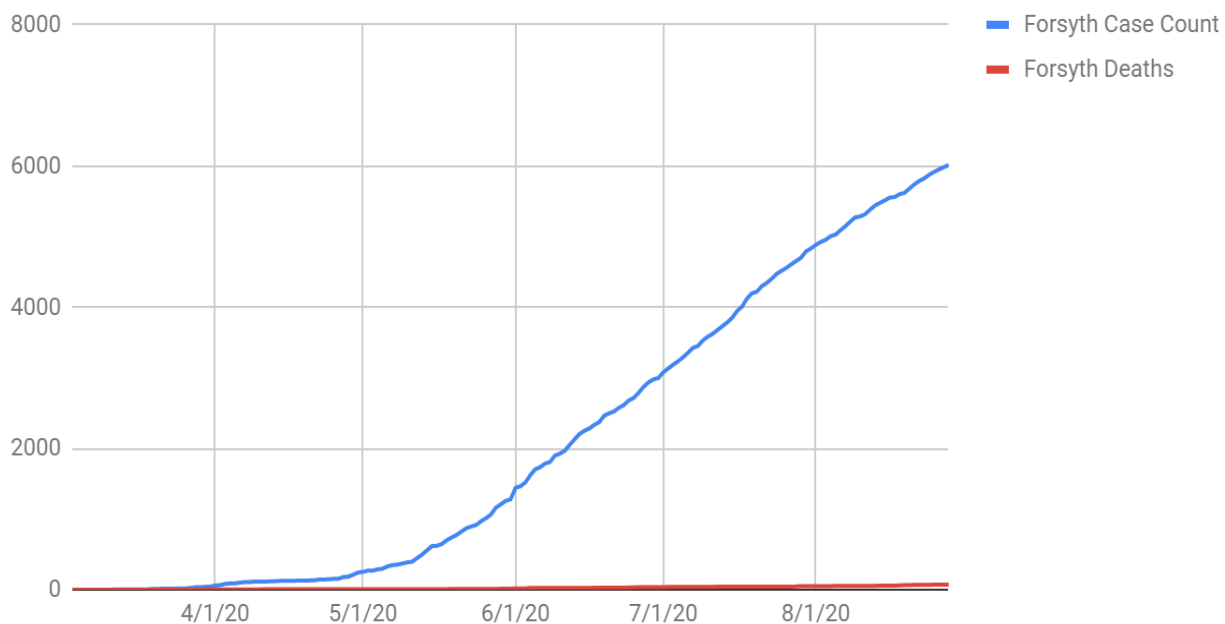

Forsyth County COVID-19 Cases

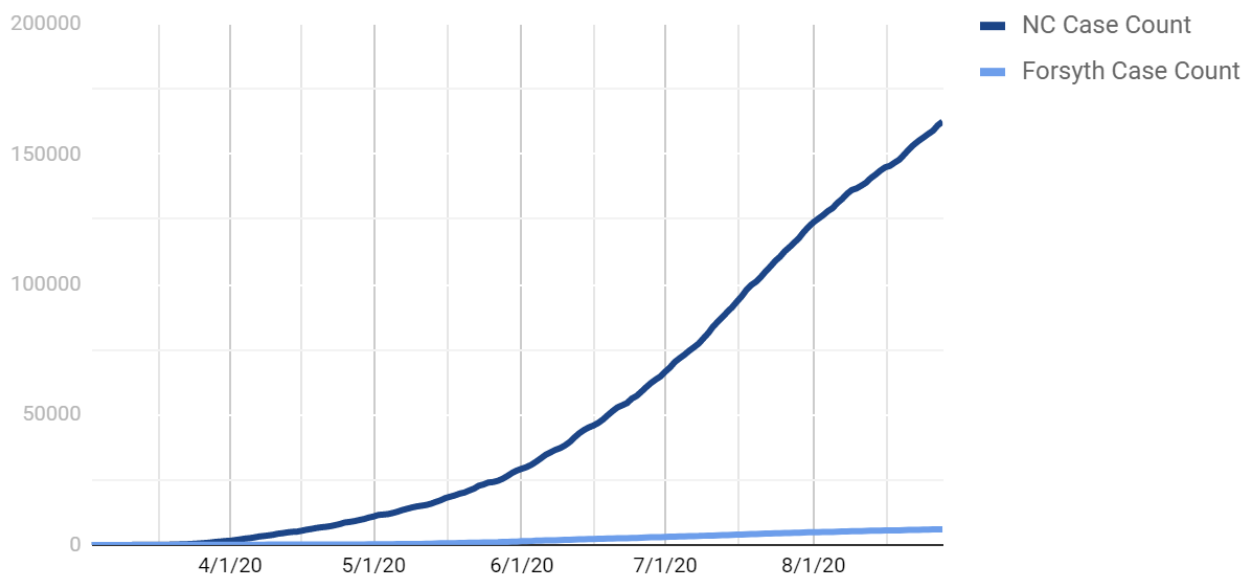


Active and recovered data starting May 1, 2020
