## COVID-19 Daily Briefing

August 21, 2020

Updated weekdays by approximately 12:30pm

Fifty-nine new cases and three deaths have been reported since yesterday's daily briefing was issued. There have been 5,740 laboratory-confirmed cases in Forsyth County. All cases reported by the Forsyth County Department of Public Health are Forsyth County residents. Of the 5,740, 5,025 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

The Public Health Director will provide a detailed briefing at 2:00pm at the beginning of the August 27th Board of County Commissioners meeting, which will be conducted remotely. The Public Health Director will hold a Question & Answer session with the media at 4:00pm on August 27th. The call-in information will be sent to the media next week.

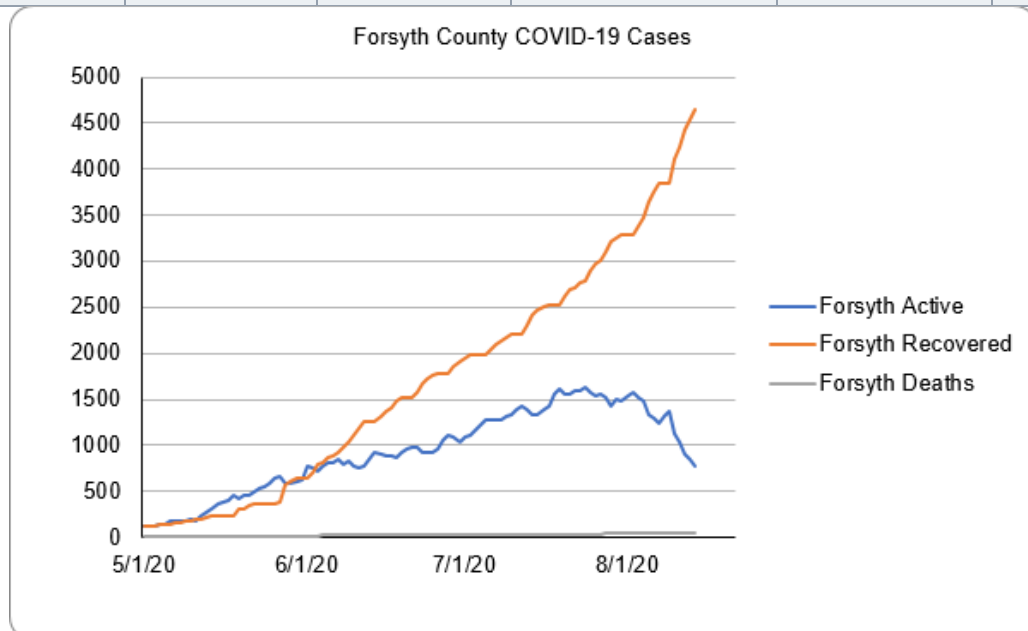

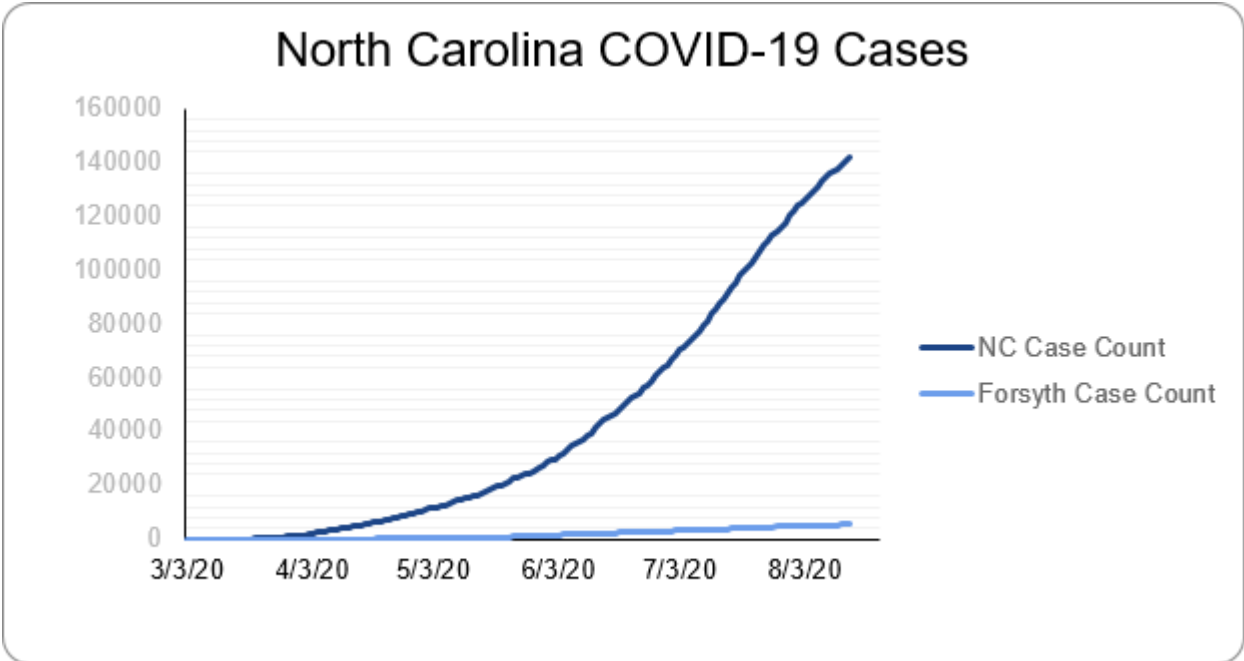
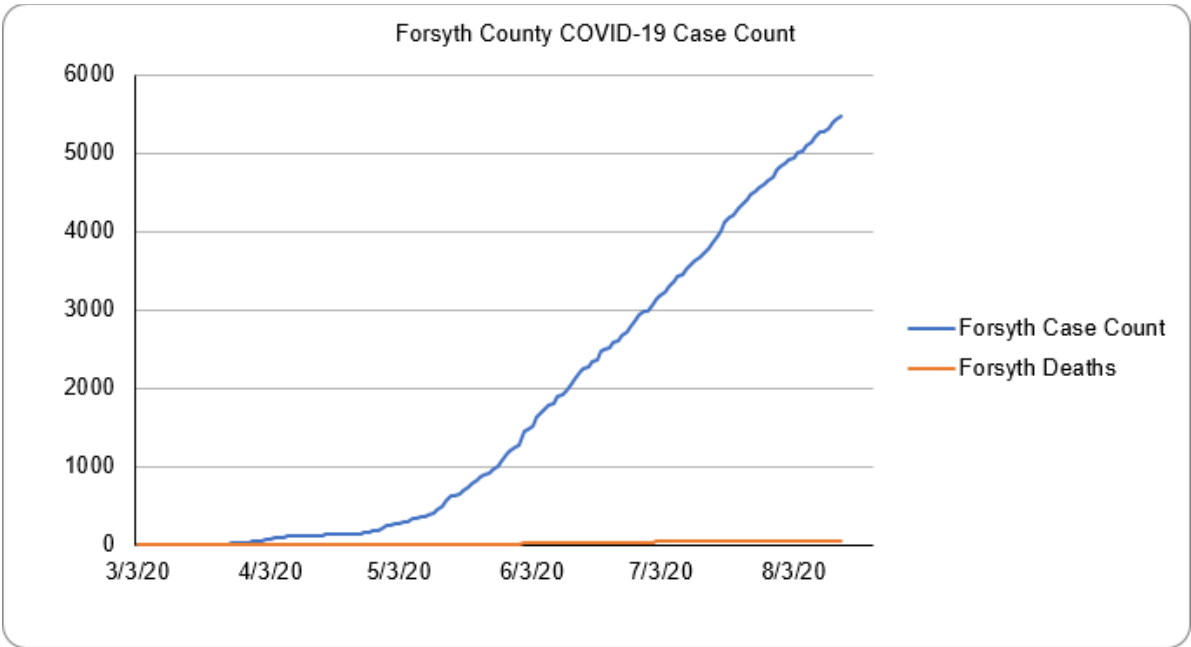
