

Forsyth County Government

COVID-19 Daily Briefing

September 30, 2020

Updated weekdays by approximately 12:30pm

Thirty new cases have been reported since yesterday's daily briefing was issued. There have been 7,097 laboratory-confirmed cases in Forsyth County. All daily cases reported by the State are presumed Forsyth County residents but may later transfer to another county if the case is later identified as not residing in Forsyth County. Of the 7,097, 6,515 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

The Public Health Director will provide a detailed briefing at 2:00pm at the beginning of the October 1st Board of County Commissioners meeting, which will be conducted remotely. 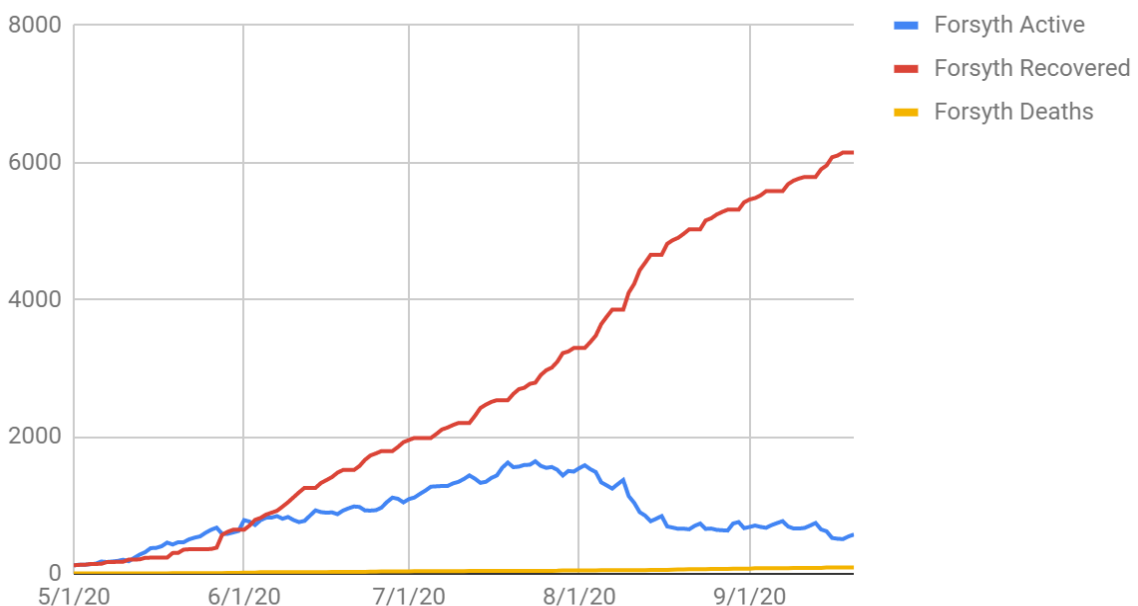
Public Health Director Comment

Public Health Director Joshua Swift commented, "Nearly half of the COVID-19 cases in Forsyth County are 34 years of age or younger. Although this age group is typically considered a lower risk for having complications from COVID-19, serious and sometimes deadly complications can occur."

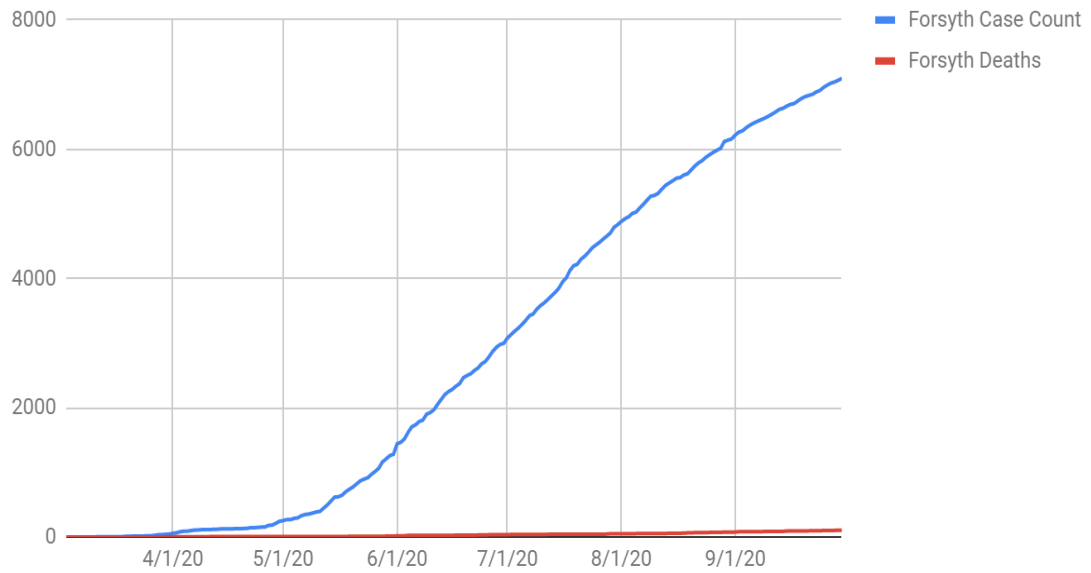

Forsyth County COVID-19 Cases

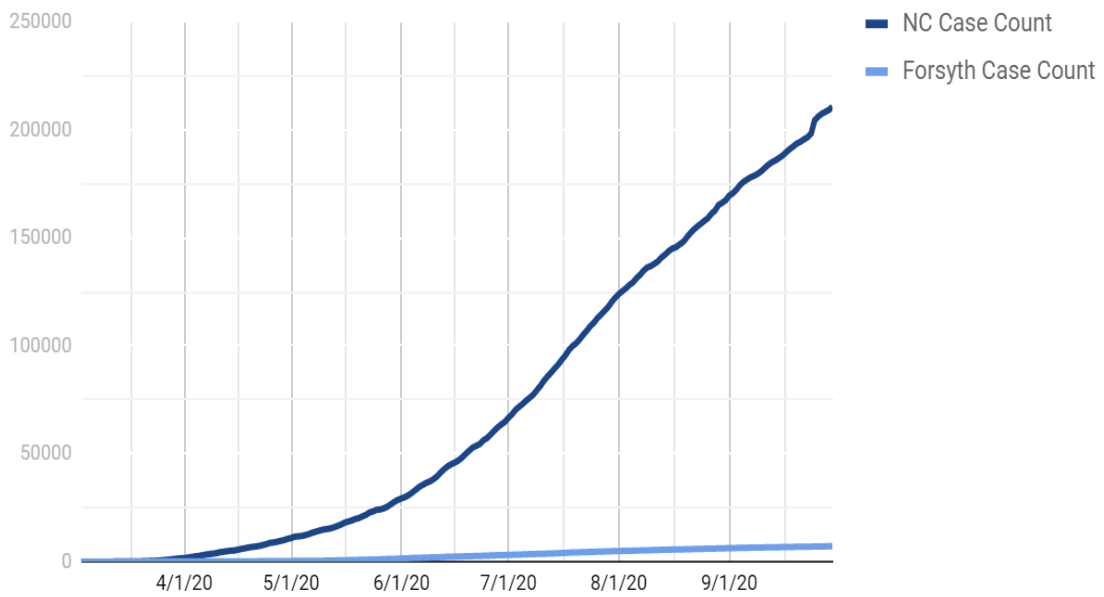


Active and recovered data starting May 1, 2020
