

# Forsyth County Government

## COVID-19 Daily Briefing

October 1, 2020

Updated weekdays by approximately 12:30pm

Eighty-five new cases and one death have been reported since yesterday's daily briefing was issued. There have been 7,182 laboratory-confirmed cases in Forsyth County. All daily cases reported by the State are presumed Forsyth County residents but may later transfer to another county if the case is later identified as not residing in Forsyth County. Of the 7,182, 6,545 are presumed recovered. The case count is subject to change throughout the day but will only be reported once per day in the daily briefing.

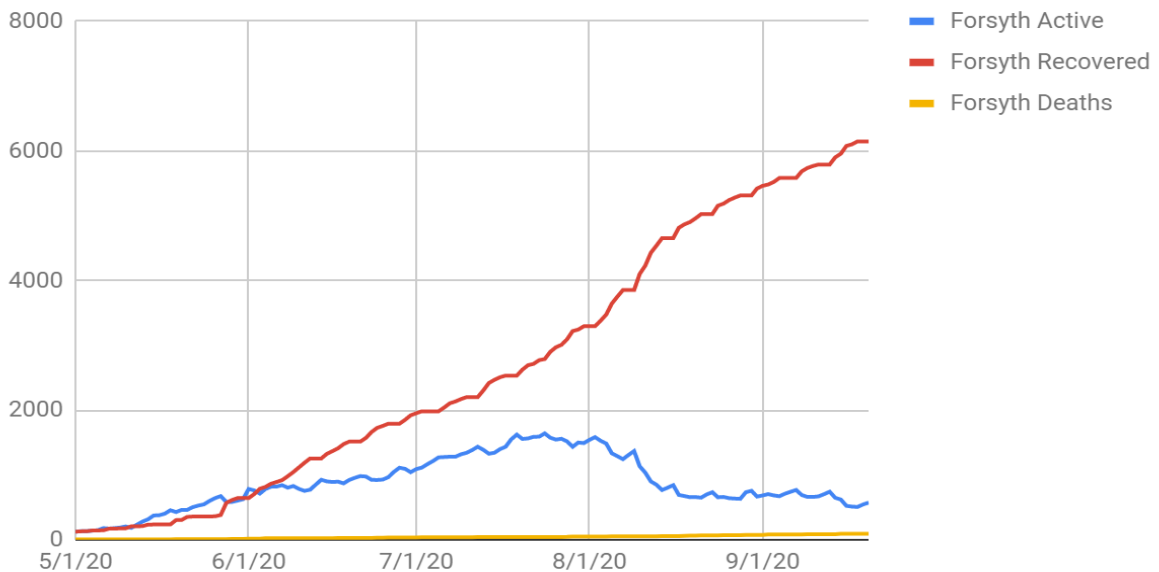
### Public Health Director Comment

Public Health Director Joshua Swift commented, "On September 29, NCDHHS reported technical issues which prevented some laboratory data files from being processed in the NC COVID reporting system. As a result, cases and test data is likely the cause for the higher case count reported today. We will continue to monitor the daily case count and report any trends should they develop."

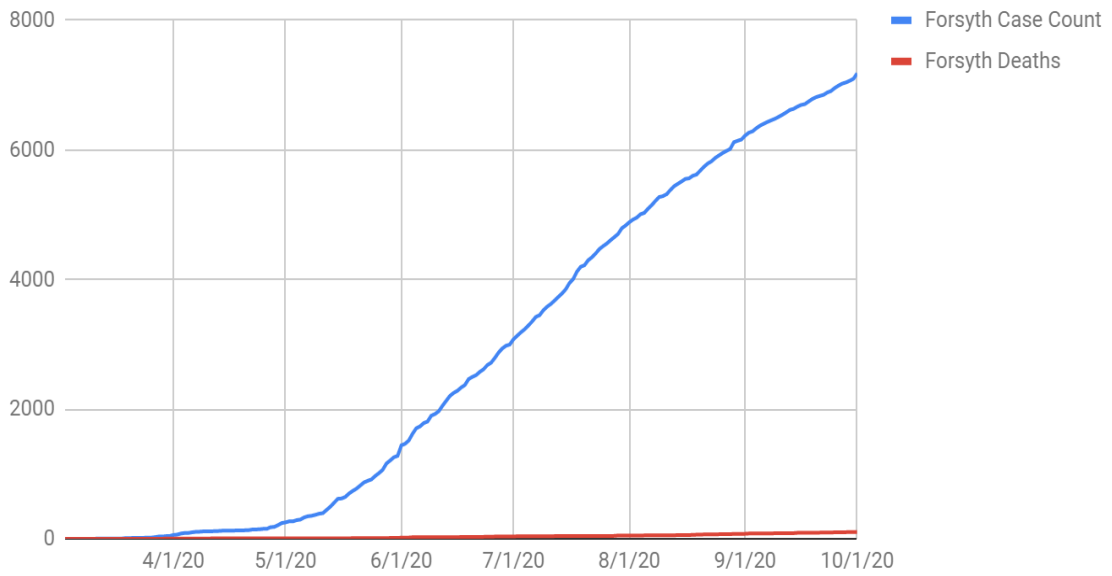

### Forsyth County COVID-19 Cases

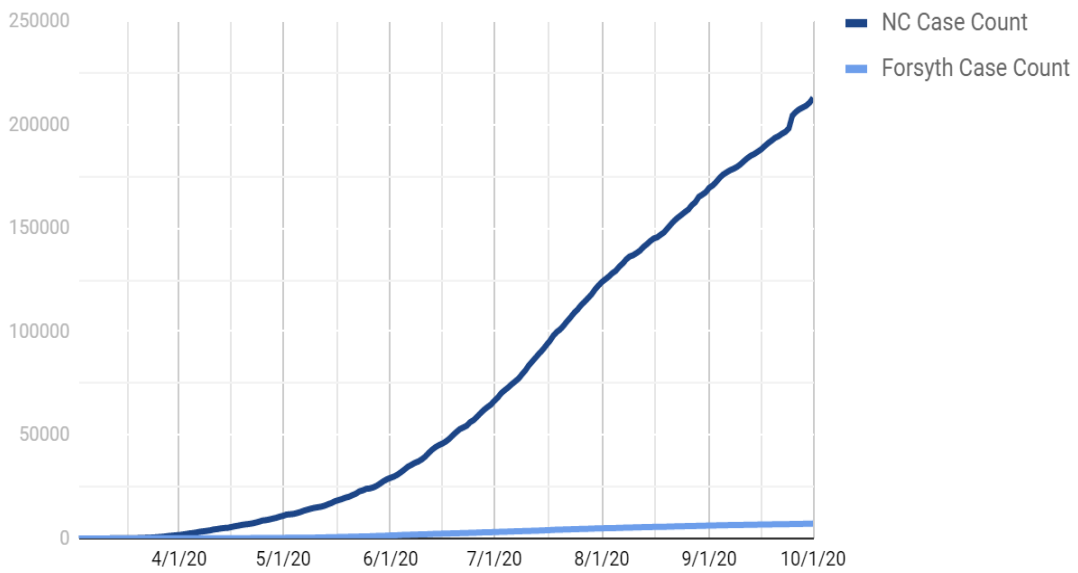


Active and recovered data starting May 1, 2020
